To accept the management of any trust shall have also the power to frame rules and bye laws under its constitution.

Meeting of Board of Trustees may be held at such time, at such place and on such dates as may be agreed upon by the trustees. Such meetings may be summoned by managing trustee or any one or more

of the trustees by giving at least 21 (twenty one) days notice in writing. The Accounting year of the Trust shall be the financial year ending on 31st March every year.
