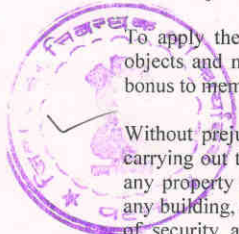
#### Main Objects of the Trust shall be:-

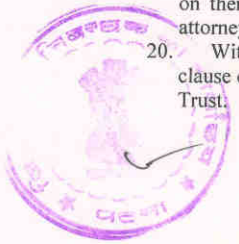
